



Introduction

Tribology, a multidisciplinary field of science and technology of interacting surfaces in relative motion, has assumed significant importance globally due to its potential to reduce the huge quantum of losses occurring through friction and wear across all the industrial sectors. The name "Tribology", denoting friction, lubrication and wear related studies, was coined by Late Prof. H. Peter Jost in the year 1966.

Tribology Society of India (TSI) is a premier professional society set up with a vision to spread awareness and practice of Tribology all across India. To fulfill this mission, the Society has been organizing International Conferences on Industrial Tribology biennially in different parts of the country, to enable the practitioners of Tribology to discuss and showcase their work in various aspects of this multidisciplinary area.

The applications of the principles of Tribology are more evident in highly energy intensive industries like steel, cement, power and mining, where even an incremental saving can add a significant amount to the productivity and thereby profitability. Therefore, the theme of the present Conference has been chosen as **"Tribology for Society"**

About IndiaTrib-2019

IndiaTrib - 2019 is the upcoming mega event in the series of the International Conferences on Industrial Tribology being organised by Tribology Society of India since the year 1997 when the first International Conference on Industrial Tribology was organised at Kolkata. Since then the story of International conferences has continued and the last in the series was the International Conference on Industrial Tribology 2017, organized again at Kolkata.

IndiaTrib – **2019** is the rechristened 10th International Conference on Industrial Tribology, since 1997, being organised by the Department of Mechanical Engineering of Indian Institute of Science (IISc), during 1-4 December 2019. The Department of Mechanical Engineering founded in 1945 is celebrating its Platinum Jubilee Year.

Call for Oral and Interactive Session Papers (Oral Short)




Authors of selected papers are required to submit extended abstract of their papers (up to 4 pages) latest by August 31, 2019. The guidelines for authors and template for the extended abstract and posters will be available for download from the TSI website.

IndiaTrib – 2019 will endeavour to give preference to papers which deal with new advancements, applications and developments in the aforesaid areas. All papers submitted for presentation in the Conference must be original and should not have been presented, published, or under consideration for publication / presentation in identical or substantially similar format. All papers will be subjected to review by a Technical Committee and the decisions will be conveyed to the authors accordingly. Authors of selected papers will be required to execute a Copyright Agreement in favor of TSI.



Schedule for IndiaTrib-2019 Education Courses

Business Meet




About Indian Institute of Science, Bangalore

Indian Institute of Science (IISc) is a public institute for research and higher education in science, engineering, design, and management. It is located in Bangalore, India, was established in 1909 with active support from Jamsetji Tata and H.H. Sir Krishnaraja Wodeyar IV, the Maharaja of Mysore. It is also locally known as the **"Tata Institute"**. It was granted the Deemed University status in 1958.

Mechanical Engineering activities at the Indian Institute of Science commenced prior to the Independence, in 1945, with the establishment of the Department of Internal Combustion Engineering. The Mechanical Engineering section of Power Engineering Department followed suit in 1951, and later became a full-fledged Department. The Department of Internal Combustion Engineering merged with the Department of Mechanical Engineering in 1970. The classrooms, laboratories and offices of the department are located at the South-East end of the Campus in three buildings — the Power Engineering Building, the "TPS" Building and the New Mechanical Engineering Building.
